RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

In consideration of being permitted to compete, officiate, observe, work for, or participate in any way in the EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials, or permission to enter to which admission by the general public is restricted or prohibited), EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin:

- 1. Acknowledges, agrees, and represents that he has or will immediately upon entering any of such RESTRICTED AREAS which he enters and he further agrees and warrants that, if at any time, he is in or about RESTRICTED AREAS and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the RESTRICTED AREAS and/or refuse to participate further in the EVENT(S)
2. HERBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, British Columbia Riders Promoting Motorsports Association (BCRPMA) , or any subdivision thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, any person in any RESTRICTED AREA, promoters, sponsors, advertisers, owners and lessees, of premises used to conduct the EVENT(S) premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, discredits, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents, and employees, all for the purposes herein after referred to as "Releasees". FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they my incur arising out of or related to the EVENT(S) WETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
4. HERBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the NEGLIGENCE OF RELEASEES or otherwise.
5. HEREBY acknowledges that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all act of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province in which the EVENT(S) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

- 1. The parent(s) and/or guardian(s) will instruct the minor participant that prior to participating in the above motorsport activity or event, he or she should inspect the facilities and equipment to be used, and if he or she believes anything to be unsafe, the participant should immediately advise the officials of such condition and refuse to participate.
2. I/We fully understand and acknowledge that:
a) There are risks and dangers associated with the participation in motorsport events and activities which could result in bodily injury, partial and/or total disability, paralysis or death.
b) The social and economic losses and/or damages, which could result from those risks and dangers described above.
c) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action or inaction or negligence of others, including, but not limited to, the "Releasees named below".
d) There may be other risks not known to us or are not reasonable foreseeable at this time.
3. I/We accept and assume such risks and responsibility for the loss and/or damages following such injury, disability, paralysis or death, however cause and whether caused in whole or in part by the negligence of the "Releasees" named below.
4. I/WE RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the promoter, participants, the British Columbia Riders Promoting Motorsports Association, or any subdivision thereof, track operator, track owner, officials, car owners, drivers pit crews, any persons in any restricted areas, promoters sponsors, advertisers, owner lessees of premises used to conduct the event and each of them, their officer, agents, and employees, all for the purposes herein referred to as "Releasees", from all liability to the undersigned, my/our personal representatives, assigns, executors, heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including but not limited to the death of the participant or damage to the property, caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise.
